The Humboldt School Board of Education held a regular meeting at 5:30pm on Monday, December 18, 2023 at the Administration Office Board Room. Roll Call-Satern-Aye, Mertz-Aye, and Clark-Aye, Davis joined the meeting at 5:44pm. Myott was absent.
