Mease Elementary and Twin Rivers Elementary will be participating in the Non Congregate Summer Food Service Program. Meals will be provided to all children without charge and are the same for all children regardless of race, color, national origin, sex, age or disability, there will be no discrimination in the course of the meal service. Meals will be provided for pick up at the sites, dates, and times as follows:

Mease Elementary and Twin Rivers Elementary June 3, June 6, June 10, June 13, June 17, June 20, June 24, June 27, July 1, July 8, July 11, July 15, July 18, July 22, July 25, July 29, and August 1.

Time for pick up will be 6:30a -9a, 12p-1p, 4p-6p at the front entrance of each location. You will receive 3 days of meals on Monday and 4 days of meals on Thursday for breakfast and lunch.

Parents are asked to sign up by providing: parents name, number of meals needed for children in household, phone number, which location they will be picking up from and time slot they will be coming. There will be a google form available to complete sign up or the information can be emailed to mbusick@opaafood.com Extra meals will be available for those that miss the sign up.

Taft Elementary will be participating in the Congregate Summer Food Service Program. Meals will be provided to children participating in summer school without charge and are the same for all children regardless of race, color, national origin, sex, age or disability, there will be no discrimination in the course of the meal service. Meals provided to students will be consumed on site Monday through Friday, students will then have the option to take home meals for Saturday and Sunday. Breakfast will be served from 7:30a-8a, lunch will be served from 11:15a-12:30p.

Adults may purchase meals at a price of \$3.00 for breakfast and \$4.50 for lunch

Menus for all locations will be posted at a later date. All meals will come with heating and storage instructions to assure food safety.
